Submission Requirements:

- Completed Work Comp ACORD Application
- ➤ 4 years of currently valued loss runs (or as many years as applied)
- > Submitted loss runs must be valued within 95 days of the effective date

Contractors

- No heavier contracting exposures such as roofers, framers, excavation/demolition, etc. Can consider higher severity exposure risks such as wallboard, commercial painting, etc.
- > No work over 2 stories (30 feet)

TSRP

- Aircraft Operation
- Any operation in which any radioactive substance is used
- Any operation in which mold or asbestos removal is performed
- Construction or maintenance of tunnels or subways more than 50 feet in length
- Diving Exposure
- Drilling for oil or natural gas, refining of petroleum, or construction or operation of pipeline for transmission of oil or gas
- Excavation greater than 6 ft, blasting, or the shoring, moving or wrecking of buildings or structures
- Framing contractors
- Group transportation (transport of 5 or more employees in any one vehicle at a time)
- Height exposure above two stories
- Livestock
- Long Haul trucking (greater than 500 miles in one direction)
- Manufacture of any acid or chemical
- Manufacture of gas under pressure

- Manufacture, storage, sale, handling or distribution of any explosive, ammunition, magnesium, fuse, fireworks, celluloid or pyroxylin
